Situated in the State of Ohio, County of Franklin, City of Columbus, part of Quarter Township 3, Township 1, Range 16, United States Military Lands and being part of a 1.170 acre tract of land in the name of Moo Moo East Broad, LLC, an Ohio limited liability company, as described in IN. 200810170154428, all records are on file in the Franklin County Recorder's Office, and being a tract of land lying on the left side of the centerline of Right of Way of State Route 16 (East Broad Street), hereafter referred to as S.R. 16, as shown on the FRA-16-7.79 plans made by the Ohio Department of Transportation, and is more particularly described as follows:

Beginning for Reference at a concrete monument found in the southerly Right of Way line of said S.R. 16 (East Broad Street), being 33.00 feet right of centerline Station 205+00.00 as delineated in the FRA-16-7.79 centerline plat as recorded in Plat Book 29, Page 4;

Thence North 08°08'48" West, perpendicular to and leaving said southerly Right of Way line a distance of 33.00 feet to a point in said centerline, being centerline Station 205+00.00;

Thence South 81°51'12" West, with said FRA-16-7.79 centerline and the southerly line of a 0.757 acre tract of land in the name of the City of Columbus as described in IN. 201710060139818, a distance of 534.94 feet to a point of at centerline Station 199+65.06;

Thence North 08°07'11" West, with the westerly line of said 0.757 acre tract and the easterly line of a 0.615 acre tract of land in the name of the City of Columbus as described in IN. 201712010169496, a distance of 110.00 feet to a point in the northerly Right of Way line of said S.R. 16, the northeasterly corner of said 0.615 acre tract and the southeasterly corner of a 1.429 acre tract in the name of GCR Retail, LLC, an Ohio Limited Liability Company, as described in

IN. 201802280027766, being 110.00 feet left of centerline Station 199+65.11, referenced by a ¾" inside diameter iron pipe found, which bears South 15°22'50" East, a distance of 1.15 feet, being 108.86 feet left of centerline Station 199+65.26, and being the **True Place of Beginning** for the tract of land herein being described;

Thence North 08°07'11" West, with the easterly line of said 1.429 acre tract, a distance of 8.00 feet to an iron pipe set 118.00 feet left of centerline Station 199+65.11;

Thence through said 1.170 acre tract the following two (2) courses:

1. North 81°51'12" East, a distance of 140.89 feet to an iron pipe set 118.00 feet left of centerline Station 201+06.00;
2. North 48°12'52" East, a distance of 46.94 feet to an iron pipe set in the westerly line of a 16.879 acre tract of land in the name of Columbus East Senior Living, LLC, an Ohio limited liability company as described in IN. 201711130159656, being 144.00 feet left of centerline Station 201+45.08;

Thence with said westerly line, the following two (2) courses:

1. South 04°05'02" West, a distance of 27.55 feet to an iron pin set 117.08 feet left of centerline Station 201+39.24;
2. South 29°42'08" West, a distance of 8.96 feet to an iron pipe set in said northerly Right of Way line and the northerly line of said 0.757 acre tract, being 110.00 feet left of centerline Station 201+33.74 and referenced by a ¾" inside diameter iron pipe found bearing South 39°02'21" West a distance of 1.65 feet and being 108.88 feet left of centerline Station 201+32.53;

Thence South 81°51'12" West, with said northerly Right of Way line and said northerly line, a distance of 168.63 feet to the **True Place of Beginning**.

The above described area contains 0.041 acres, more or less, of which the present road occupies 0.000 acres, more or less, which is part of Franklin County Auditor's Permanent Parcel number 520-287567-00.

Iron pins set are 13/16" inside diameter iron pipe, 30" long with a yellow cap stamped "OHM". Bearings for this description are based on Ohio State Plane Coordinates, South Zone, NAD 83 (2007) Datum as established utilizing a GPS survey performed in November 2017, holding North 82°20'12" East for the centerline of East Broad Street (State Route 16).
