Thence North 08°08'48" West, perpendicular to and leaving said southerly Right of Way line a distance of 33.00 feet to a point in said centerline, being centerline Station 205+00.00;

Thence North 81°51'12" East, with said FRA-16-7.79 centerline, a distance 420.54 feet to the northwesterly corner of a 2.103 acre tract of land in the name Eastglen Professional Condominium Association, as described in IN. 200309170297599 and as delineated in Eastglen Professional Condominium of record in Condominium Plat Book 121, Page 43, at centerline Station 209+20.54;
