[Surveyor's description of the premises follows]

Situated in the State of Ohio, County of Franklin, City of Columbus, part of Quarter Township 3, Township 1, Range 16, United States Military Lands and being part of a 1.400 acre tract of land in the name of Indus Broad Street Hotel, LLC, an Ohio Limited Liability Company as described in IN. 201909200123231, formerly in the name of Deborah L. Shub, Trustee of the Deborah L. Shub Trust dated July 19, 1986 as described in IN 201804270055695, all records are on file in the Franklin County Recorder's Office, and being a tract of land lying on the left side of the centerline of Right of Way of State Route 16 (East Broad Street), hereafter referred to as S.R. 16, as shown on the FRA-16-7.79 plans made by the Ohio Department of Transportation, and is more particularly described as follows:

Beginning for Reference at a concrete monument found in the southerly Right of Way line of said S.R. 16 (East Broad Street), being 33.00 feet right of centerline Station 205+00.00 as delineated in the FRA-16-7.79 centerline plat as recorded in Plat Book 29, Page 4;

Thence North 08°08'48" West, perpendicular to and leaving said southerly Right of Way line a distance of 33.00 feet to a point in said centerline, being centerline Station 205+00.00;

Thence North 81°51'12" East, with said FRA-16-7.79 centerline, a distance of 209.29 feet to a point at centerline Station 207+09.29, passing the centerline intersection of said S.R. 16 (East Broad Street) and Outerbelt Street (80.00' R/W);

Thence North 08°08'48" West, perpendicular to said centerline, a distance of 110.00 feet to a point in the northerly Right of Way line of said S.R. 16 (East Broad Street), being 110.00 feet left of centerline Station 207+09.29 and the **True Place of Beginning** for the tract of land herein being described;

Thence North 50°46'30" West, through said 1.400 acre tract, a distance of 29.42 feet to a point in the easterly Right of Way line of said Outerbelt Street, being 131.64 feet left of centerline Station 206+89.36;

Thence with said easterly Right of Way line, a curve to the right having a radius of 264.66 feet, an arc length of 12.83 feet, a central angle of 02°46'39", a chord bearing of North 02°04'15" West and a chord distance of 12.83 feet to a point 144.40 feet left of centerline Station 206+90.72;

Thence through said 1.400 acre tract, the following two (2) courses:

1. South 54°24'45" East, a distance of 28.06 feet to a point 125.00 feet left of centerline Station 207+11.00;
2. North 81°51'12" East, a distance of 164.51 feet to a point in the westerly line of a 5.000 acre tract of land in the name of SH 724 LLC, a Delaware limited liability company as described in IN. 200812220182539, being 125.00 feet left of centerline Station 208+75.51;

Thence South 03°41'05" West, with said westerly line, a distance of 15.33 feet to a point in said northerly Right of Way line, being 110.00 feet left of centerline Station 208+72.36;

Thence South 81°51'21" West, with said northerly Right of Way line, a distance of 163.07 feet to the **True Place of Beginning**.

The above described area contains 0.063 acres, more or less, which is part of Franklin County Auditor's Permanent Parcel number 520-214704-00.

Bearings for this description are based on Ohio State Plane Coordinates, South Zone, NAD 83 (2007) Datum as established utilizing a GPS survey performed in November 2017, holding North 82°20'12" East for the centerline of East Broad Street (State Route 16).

The stations referred to in this description are from the centerline of Right-of-Way of State Route 16, as found on the FRA-16-7.79 centerline plat as recorded in Franklin County Recorder's Office in Plat Book 29 Page 4.

The stations are shown on the FRA SR 16 8.24 centerline plat, as recorded in Franklin County Recorder's Office in Plat Book 132 Page 106-109.
