Situated in the State of Ohio, City of Columbus, Franklin County, Section 1, Township 5, Range 22, Refugee Lands and being part of Lot 107 in the Amended Plat of Bexley Heights Add. as recorded in Plat Book 18, page 31, a tract conveyed to Nora Metzger in Instrument 200212120319388 in the Franklin County Recorder's Office. The below described parcel laying on the left side of the centerline of proposed right of way for Cassady Avenue in project FRA-C.R. 96-1.71. (Cassady Ave.) as platted by 2LMN, Inc. and recorded in Instrument 202109170166308, being Plat Book 131, Page 66, and being more particularly described as follows:

COMMENCING at a point at the southeast corner of said Lot 107, said point being 40.00 feet left of the proposed centerline of Cassady Avenue at station 14+42.57 and being the **TRUE POINT OF BEGINNING** for the parcel herein described:

- 1) **Thence**, along south line of said Lot 107, **North 85 degrees 11 minutes 57 seconds West, 8.00 feet** to a point, said point being 48.00 feet left of the centerline of proposed right of way and construction for Cassady Avenue at station 14+42.58;
- 2) **Thence**, across said Lot 107, **North 04 degrees 48 minutes 41 seconds East, 40.00 feet** to a point on the grantor's north line, said point being 48.00 feet left of the centerline of proposed right of way and construction for Cassady Avenue at station 14+82.58;
- 3) **Thence**, along the north line of said Lot 107, **South 85 degrees 11 minutes 57 seconds East, 8.00 feet** to a point at the grantor's northeast corner on the westerly existing Right of Way for Cassady Avenue, said point being 40.00 feet left of the centerline of proposed right of way and construction for Cassady Avenue at station 14+82.57;
- 4) **Thence**, along the east line of said Lot 107 and the westerly existing Right of Way for Cassady Avenue, **South 04 degrees 47 minutes 52 seconds West, 40.00 feet** to the **TRUE POINT OF BEGINNING**, containing 0.007 acres.

All irons pins set are 5/8 inch x 30 inch rebar with a 1 inch plastic cap stamped "2LMN, Inc".

Grantor claim title by Instrument 200212120319388, as recorded in the Franklin County Recorder's Office.

The bearings shown hereon are based on the centerline of Cassady Avenue from Margaret Street to East 7th Avenue as being North 09 degrees 35 minutes 04 seconds East, from an adjusted field survey using GPS methods from the nearby City of Columbus monument (COC32-82), nearby United States Geological Survey monument (802.52USGS), and Continually Operating Reference Station (CORS) COLB, based on the Ohio State Plane Coordinate System, South Zone, and North American Datum 1983 (NSRS 2007) scaled to ground by 1.000042617 about the projection origin (0,0).
