Situated in the State of Ohio, City of Columbus, Franklin County, Quarter Township 4, Township 1, Range 18, U.S. Military Lands and being parts of Lot 197, of Indianola Park View Addition as recorded in Plat Book 9, page 1-B and conveyed to Luke A. Wilson in Instrument 199901120009283 in the Franklin County Recorder's Office. The below described parcel laying on the left side of Arcadia Avenue, and being more particularly described as follows:

COMMENCING at an 8 inch mag nail set at the grantor's southwest corner being the southwest corner of said Lot 197, and being on the north existing Right of Way line of a 20 foot alley as dedicated in said Plat Book 9, Page 1-B; Thence, along the grantor's south line, being the north existing Right of Way line of said 20 foot alley, South 86 degrees 48 minutes 24 seconds East 3.83 feet to an 8 inch mag nail set; Thence, across the grantor's tract, North 03 degrees 11 minutes 36 seconds East, 1.44 feet to an iron pin set, said iron pin set being the **TRUE POINT OF BEGINNING** for the parcel herein described:

- 1) **Thence**, across the grantor's tract, **North 03 degrees 11 minutes 36 seconds East, 2.06 feet** to a point;
- 2) **Thence**, across the grantor's tract, **South 86 degrees 48 minutes 24 seconds East, 19.00 feet** to a point;
- 3) **Thence**, across the grantor's tract, **South 03 degrees 11 minutes 36 seconds West, 1.82 feet** to an iron pin set on the north proposed Right of Way of said 20 foot alley;
- 4) **Thence**, across the grantor's tract and the north proposed Right of Way of said 20 foot alley, **North 86 degrees 48 minutes 24 seconds West, 11.69 feet** to an iron pin set;
- 5) **Thence**, across the grantor's tract and the north proposed Right of Way of said 20 foot alley, **South 03 degrees 11 minutes 36 seconds West, 0.50 feet** to an iron pin set;

- 6) **Thence**, across the grantor's tract and the north proposed Right of Way of said 20 foot alley, **North 87 degrees 15 minutes 25 seconds West, 4.81 feet** to an iron pin set;

- 7) **Thence**, across the grantor's tract and the north proposed Right of Way of said 20 foot alley, **North 80 degrees 09 minutes 58 seconds West, 2.51 feet** to the **TRUE POINT OF BEGINNING**, containing 0.001 acres.

The parcel of land described contains, 0.001 acres, more or less and is located in Franklin County Auditor's Parcel Number 010-038980-00, including the present road occupies 0.000 acres, more or less.

All iron pins set are 5/8 inch x 30 inch rebar with a 1 inch plastic cap stamped "2LMN, Inc".
