Situated in the City of Columbus, County of Franklin, and State of Ohio, Half Section 47, Township 12, Range 21 of the Refugee Lands, and being in Lot 397 of Walnut Bluff No. 1 as recorded in Plat Book 34, Page 42, as conveyed to Deltrina Mackey, by Instrument Number 201908270109989, all references being to the Franklin County Recorder's Office, Franklin County, Ohio, and being bounded and more particularly described as follows:

Being a parcel of land lying on the north side of the centerline of existing right-of-way of Refugee Road, being located within the following described points in the boundary thereof;

Beginning, for reference, at a 1" iron pin inside a monument box to be set during construction at the intersection of the existing centerline of right-of-way of Maywood Road (R/W Varies) and the existing centerline of right-of-way of Refugee Road (60' R/W), being at Station 15+99.07 in said centerline of Refugee Road;

Thence along said centerline of Refugee Road North 85° 31' 31" West a distance of 285.34 feet to Station 13+13.73 in said centerline;

Thence leaving said centerline North 4° 28' 29" East a distance of 30.00 feet to a point on the Grantor's southeasterly corner, and the southeasterly corner of said Lot 397, also being the southwesterly corner of Lot 396 of said Walnut Bluff No. 1 as conveyed to Keith S. Jablonski and Sherry L. Jablonski by Official Record 11286, Page J20, also being in the northerly right-of-way line of said Refugee Road and being 30.00 feet left of Station 13+13.73 in said centerline, said point also being the **TRUE POINT OF BEGINNING** for the parcel herein described;

Thence along said northerly right-of-way line, also being the Grantor's southerly line **North 85° 31' 31" West** a distance of **18.73 feet** to a point 30.00 feet left of Station 12+95.00 in said centerline;

Thence leaving said line, along a new line across the Grantor's tract the following two courses:

- 1) **North 4° 28' 29" East** a distance of **5.00 feet** to a point 35.00 feet left of Station 12+95.00 in said centerline;
- 2) **South 85° 31' 31" East** a distance of **18.73 feet** to a point on the Grantor's easterly line and easterly line of said lot 397 and the westerly line of said Lot 396, said point being 35.00 feet left of Station 13+13.73 in said centerline;

Thence along said Grantor's easterly line **South 4° 28' 29" West** a distance of **5.00 feet** to the **TRUE POINT OF BEGINNING**, containing 0.002 acres, of which the present road occupies 0.000 acres.

Of the above described tract 0.002 acres, including 0.000 acres of present road occupied, is located in Auditor's Parcel Number 010-133252-00.

The bearings for this description are based on Grid North, of the Ohio State Plane Coordinate System, South Zone, NAD83(2011) as determined by GNSS measurements tied to the Ohio Department of Transportation's Real-Time-Network. Control for the bearings shown herein were determined by GPS observations and establishing South 85°31'31" East for the existing centerline of right-of-way of Refugee Road. Bearings are shown to indicate angle only and are for project use only.

All stations referred to herein are from the existing centerline of right-of-way of Refugee Road as shown in plans for project Operation Sidewalks, School Sidewalks – Refugee Road on file with the City of Columbus.
