

WARRANTY DEED

Situated in the City of Columbus, County of Franklin, and State of Ohio, Half Section 47, Township 12, Range 21 of the Refugee Lands, and being in Lot 16 of Amberly Subdivision as recorded in Plat Book 36, Page 114, as conveyed to Zvikauri LLC, An Ohio Limited Liability Company, by Instrument Number 202110050179399, all references being to the Franklin County Recorder's Office, Franklin County, Ohio, and being bounded and more particularly described as follows:

Being a parcel of land lying on the south side of the centerline of existing right-of-way of Refugee Road, being located within the following described points in the boundary thereof;

Beginning, for reference, at a 1" iron pin inside a monument box to be set during construction at the intersection of the existing centerline of right-of-way of Maywood Road (R/W Varies) and the existing centerline of right-of-way of Refugee Road (60' R/W), being at Station 15+99.07 in said centerline of Refugee Road;

Thence along said centerline of Refugee Road North 85° 31' 31" West a distance of 108.53 feet to Station 14+90.54 in said centerline;

Thence leaving said centerline South 4° 28' 29" West a distance of 30.00 feet to an iron pin set at the Grantor's northeasterly corner and the northeasterly corner of said Lot 16, also being the northwesterly corner of Lot 17 of said Amberly Subdivision as conveyed to Shelia Roebuck by Instrument Number 201001110003478, also being in the southerly right-of-way line of said Refugee Road, said pin being 30.00 feet right of Station 14+90.54 in said centerline and being the **TRUE POINT OF BEGINNING** for the parcel herein described;

Thence along the Grantor's easterly line, easterly line of Lot 16, and the westerly line of said Lot 17, **South 4° 28' 29" West** a distance of **7.00 feet** to an iron pin set 37.00 feet right of Station 14+90.54 in said centerline;

Thence leaving said line, along a new line across the Grantor's tract the following two courses:

- 1) **North 85° 31' 31" West** a distance of **13.54 feet** to an iron pin set 37.00 feet right of Station 14+77.00 in said centerline;
- 2) **North 4° 28' 29" East** a distance of **7.00 feet** to an iron pin set in said Grantor's northerly line, northerly line of said Lot 16, and said southerly right-of-way line of Refugee Road, said pin being 30.00 feet right of Station 14+77.00 in said centerline;

Thence along said line **South 85° 31' 31" East** a distance of **13.54 feet** to the **TRUE POINT OF BEGINNING**, containing 0.002 acres, of which the present road occupies 0.000 acres.

Of the above described tract 0.002 acres, including 0.000 acres of present road occupied, is located in Auditor's Parcel Number 530-139720-00.

The bearings for this description are based on Grid North, of the Ohio State Plane Coordinate System, South Zone, NAD83(2011) as determined by GNSS measurements tied to the Ohio Department of Transportation's Real-Time-Network. Control for the bearings shown herein were determined by GPS observations and establishing South 85°31'31" East for the existing centerline of right-of-way of Refugee Road. Bearings are shown to indicate angle only and are for project use only.

All stations referred to herein are from the existing centerline of right-of-way of Refugee Road as shown in plans for project Operation Sidewalks, School Sidewalks – Refugee Road on file with the City of Columbus.
