

# **TEMPORARY CONSTRUCTION EASEMENT**

**0.010 Acre Tract (425.19 S.F.)**

Situated in the City of Columbus, County of Franklin, and State of Ohio, Half Section 47, Township 12, Range 21 of the Refugee Lands, and being in Lot 233 of Amberly Subdivision as recorded in Plat Book 36, Page 114, as conveyed to Kenneth A. Brush, D.V.M., by Official Records 10776, Page D18, all references being to the Franklin County Recorder's Office, Franklin County, Ohio, and being bounded and more particularly described as follows:

Being a parcel of land lying on the south side of the centerline of existing right-of-way of Refugee Road, being located within the following described points in the boundary thereof;

Beginning, for reference, at a 1" iron pin inside a monument box to be set during construction at the intersection of the existing centerline of right-of-way of Maywood Road (R/W Varies) and the existing centerline of right-of-way of Refugee Road (60' R/W), being at Station 15+99.07 in said centerline of Refugee Road;

Thence along said centerline of Refugee Road South 85° 31' 31" East a distance of 111.93 feet to Station 17+11.00 in said centerline;

Thence leaving said centerline South 4° 28' 29" West a distance of 30.00 feet to an iron pin set at the Grantor's northeasterly corner and northeasterly corner of said Lot 233, also being the northwesterly corner of Lot 234 of said Amberly Subdivision as conveyed to 4969 Refugee RD. L.L.C. by Instrument Number 199807140176003, also being in the southerly right-of-way line of said Refugee Road and being 30.00 feet right of Station 17+11.00 in said centerline;

Thence along the Grantor's easterly line and easterly line of said Lot 233, and the westerly line of said Lot 234 South 4° 18' 34" West a distance of 7.00 feet to an iron pin set in a new right-of-way line 37.00 feet right of Station 17+11.02 in said centerline, said pin also being the **TRUE POINT OF BEGINNING** of the parcel herein described;

Thence along said Grantor's easterly line and said westerly line of Lot 234 **South 4° 18' 34" West** a distance of **7.00 feet** to a point in the Grantor's easterly line being 44.00 feet right of Station 17+11.04 in said centerline;

Thence leaving said line, along a new line across the Grantor's tract the following five courses:

- 1) **North 79° 57' 33" West** a distance of **41.24 feet** to a point 40.00 feet right of Station 16+70.00 in said centerline;
- 2) **North 85° 31' 31" West** a distance of **30.00 feet** to a point 40.00 feet right of Station 16+40.00 in said centerline;
- 3) **South 55° 48' 53" West** a distance of **12.81 feet** to a point 48.00 feet right of Station 16+30.00 in said centerline;
- 4) **South 4° 28' 29" West** a distance of **10.00 feet** to a point 58.00 feet right of Station 16+30.00 in said centerline;
- 5) **North 85° 31' 31" West** a distance of **5.93 feet** to a point in the Grantor's westerly line, said line also being the easterly right-of-way line of Maywood Road, being 58.00 feet right of Station 16+24.07 in said centerline;

Thence along said line **North 4° 28' 29" East** a distance of **8.00 feet** to an iron pin set 50.00 feet right of Station 16+24.07 in said centerline;

Thence leaving said line, along a new right-of-way line the following two courses:

- 1) **North 41° 50' 28" East** a distance of **16.36 feet** to an iron pin set 37.00 feet right of Station 16+34.00 in said centerline;
- 2) **South 85° 31' 31" East** a distance of **77.02 feet** to the **TRUE POINT OF BEGINNING**, containing 0.010 acres, of which the present road occupies 0.000 acres.

Of the above described tract 0.010 acres, including 0.000 acres of present road occupied, is located in Auditor's Parcel Number 530-139937-00.

The bearings for this description are based on Grid North, of the Ohio State Plane Coordinate System, South Zone, NAD83(2011) as determined by GNSS measurements tied to the Ohio Department of Transportation's Real-Time-Network. Control for the bearings shown herein were determined by GPS observations and establishing South 85°31'31" East for the existing centerline of right-of-way of Refugee Road. Bearings are shown to indicate angle only and are for project use only.

All stations referred to herein are from the existing centerline of right-of-way of Refugee Road as shown in plans for project Operation Sidewalks, School Sidewalks – Refugee Road on file with the City of Columbus.

Monuments referred to as iron pins set are  $\frac{5}{8}$ " x 30" topped by a yellow plastic cap stamped "R/W, CMT, P.S. 7357". Right of way monuments called for as set herein shall be set upon completion of the acquisition process.
