

**PERMANENT EASEMENT**

Situated in the City of Columbus, County of Franklin, and State of Ohio, Half Section 47, Township 12, Range 21 of the Refugee Lands, and being part of Lot 242 of Amberly Subdivision as recorded in Plat Book 36, Page 114, as conveyed to Fern E. Tyler, Trustee, by Official Record 33871, Page A05, all references being to the Franklin County Recorder's Office, Franklin County, Ohio, and being bounded and more particularly described as follows:

Being a parcel of land lying on the south side of the centerline of existing right-of-way of Refugee Road, being located within the following described points in the boundary thereof;

Beginning, for reference, at a 1" iron pin inside a monument box to be set during construction at the intersection of the existing centerline of right-of-way of Fleet Road (60' R/W) and the existing centerline of right-of-way of Refugee Road (60' R/W), being at Station 23+76.83 in said centerline of Refugee Road;

Thence along said centerline of Refugee Road North 85° 31' 31" West a distance of 104.85 feet to Station 22+71.98 in said centerline;

Thence leaving said centerline South 4° 28' 29" West a distance of 30.00 feet to an iron pin set at the Grantor's northeasterly corner and the northeasterly corner of said Lot 242, also being the northwesterly corner of Lot 243 of said Amberly Subdivision as conveyed to Jessica Macauley by Instrument Number 202101270016601, also being in the southerly right-of-way line of said Refugee Road and being 30.00 feet right of Station 22+71.98 in said centerline, said pin also being the **TRUE POINT OF BEGINNING** of the parcel herein described;

Thence along the Grantor's easterly line and easterly line of said Lot 242, and the westerly line of said Lot 243 **South 4° 18' 34" West** a distance of **6.00 feet** to an iron pin set 36.00 feet right of Station 22+72.00 in said centerline;

Thence leaving said line, along a new line across the Grantor's tract the following two courses:

- 1) **North 85° 31' 31" West** a distance of **14.00 feet** to an iron pin set 36.00 feet right of Station 22+58.00 in said centerline;
  
- 2) **North 4° 28' 29" East** a distance of **6.00 feet** to an iron pin set in the Grantor's northerly line and northerly line of said Lot 242, also being in said southerly right-of-way line of Refugee Road, said pin being 30.00 feet right of Station 22+58.00 in said centerline,

Thence along said southerly right-of-way line **South 85° 31' 31" East** a distance of **13.98 feet** to the **TRUE POINT OF BEGINNING**, containing 0.002 acres, of which the present road occupies 0.000 acres.

Of the above described tract 0.002 acres, including 0.000 acres of present road occupied, is located in Auditor's Parcel Number 530-139946-00.

The bearings for this description are based on Grid North, of the Ohio State Plane Coordinate System, South Zone, NAD83(2011) as determined by GNSS measurements tied to the Ohio Department of Transportation's Real-Time-Network. Control for the bearings shown herein were determined by GPS observations and establishing South 85°31'31" East for the existing centerline of right-of-way of Refugee Road. Bearings are shown to indicate angle only and are for project use only.

All stations referred to herein are from the existing centerline of right-of-way of Refugee Road as shown in plans for project Operation Sidewalks, School Sidewalks – Refugee Road on file with the City of Columbus.

Monuments referred to as iron pins set are 5/8" x 30" topped by a yellow plastic cap stamped "R/W, CMT, P.S. 7357". Right of way monuments called for as set herein shall be set upon completion of the acquisition process.
