Thence along said centerline of Refugee Road South 85° 31' 31" East a distance of 114.45 feet to Station 32+70.00 in said centerline;

Thence leaving said centerline South 4° 28' 29" West a distance of 30.00 feet to a point in the Grantor's northerly line, also being the southerly right-of-way line of said Refugee Road, being 30.00 feet right of Station 32+70.00 in said centerline and being the **TRUE POINT OF BEGINNING** for the parcel herein described;

- North 31° 58' 11" West a distance of 20.20 feet to a point in the said Grantor's northerly line, also being the southerly right-of-way line of Refugee Road, being 30.00 feet right of Station 31+88.00 in said centerline;

Thence along said right-of-way line **South 85° 31' 31" East** a distance of **82.00 feet** to the **TRUE POINT OF BEGINNING**, containing 0.028 acres, of which the present road occupies 0.000 acres.

Of the above described tract 0.028 acres, including 0.000 acres of present road occupied, is located in Auditor's Parcel Number 010-104482-00.

The bearings for this description are based on Grid North, of the Ohio State Plane Coordinate System, South Zone, NAD83(2011) as determined by GNSS measurements tied to the Ohio Department of Transportation's Real-Time-Network.
