Situated in the City of Columbus, County of Franklin, and State of Ohio, Half Section 47, Township 12, Range 21 of the Refugee Lands, being a part of a 36.239-acre tract of land conveyed to The Board of Education of The City School District of Columbus, Ohio, by Deed Book 2974, Page 61 and Deed Book 3086, Page 244, all references being to the Franklin County Recorder's Office, Franklin County, Ohio, and being bounded and more particularly described as follows:

Being a parcel of land lying on the south side of the centerline of existing right-of-way of Refugee Road, being located within the following described points in the boundary thereof;

Beginning, for reference, at a 1" iron pin inside a monument box to be set during construction at the intersection of the existing centerline of right-of-way of Fleet Road (60' R/W) and the existing centerline of right-of-way of Refugee Road (60' R/W), being at Station 23+76.83 in said centerline of Refugee Road;

Thence along said centerline of Refugee Road South 85° 31' 31" East a distance of 150.09 feet to Station 25+26.92 in said centerline;

Thence leaving said centerline South 4° 28' 29" West a distance of 30.00 feet to the Grantor's northwesterly corner, also being in the southerly right-of-way line of said Refugee Road and the northeasterly corner of Lot 256 of said Amberly Subdivision as conveyed to Trudy Brown by Instrument Number 200808120123012, said point being 30.00 feet right of Station 25+26.92 in said centerline, said point also being the **TRUE POINT OF BEGINNING** for the parcel herein described;

Thence along said right-of-way line **South 85° 31' 31" East** a distance of **28.08 feet** to a point 30.00 feet right of Station 25+55.00 in said centerline;

Thence leaving said line along a new line across the Grantor's tract the following two courses:

- 1) **South 4° 28' 29" West** a distance of **5.00 feet** to a point 35.00 feet right of Station 25+55.00 in said centerline;

- 2) **North 85° 31' 31" West** a distance of **28.06 feet** to a point in the Grantor's westerly line also being the easterly line of said Lot 256 of said Amberly Subdivision as conveyed to Trudy Brown by Instrument Number 200808120123012, said point being 35.00 feet right of Station 25+26.94 in said centerline;

Thence along said line **North 4° 18' 34" East** a distance of **5.00 feet** to the **TRUE POINT OF BEGINNING**, containing 0.003 acres, of which the present road occupies 0.000 acres.

Of the above described tract 0.003 acres, including 0.000 acres of present road occupied, is located in Auditor's Parcel Number 010-104482-00.

The bearings for this description are based on Grid North, of the Ohio State Plane Coordinate System, South Zone, NAD83(2011) as determined by GNSS measurements tied to the Ohio Department of Transportation's Real-Time-Network. Control for the bearings shown herein were determined by GPS observations and establishing South 85°31'31" East for the existing centerline of right-of-way of Refugee Road. Bearings are shown to indicate angle only and are for project use only.

All stations referred to herein are from the existing centerline of right-of-way of Refugee Road as shown in plans for project Operation Sidewalks, School Sidewalks – Refugee Road on file with the City of Columbus.
