Beginning, for reference, at a 1 " iron pin inside a monument box to be set during construction at the intersection of the existing centerline of right-of-way of Brownfield Road (50' R/W) and the existing centerline of right-of-way of Refugee Road ( $60^{\prime}$ R/W), being at Station $35+03.49$ in said centerline of Refugee Road;

Thence along said centerline of Refugee Road, also being the Grantor's northerly line the following two courses:

1) South $85^{\circ} 31^{\prime} 31^{\prime \prime}$ East a distance of 112.00 feet to a magnetic spike to be set during construction at P.I. station $36+15.49$ in said centerline;
2) South $85^{\circ} 53^{\prime} 16^{\prime \prime}$ East a distance of 116.51 feet to a point at Station $37+32.00$ in said centerline;

Thence leaving said centerline South $4^{\circ} 06^{\prime} 44^{\prime \prime}$ West a distance of 30.00 feet to a point in the southerly right-of-way line of said Refugee Road, being 30.00 feet right of Station $37+32.00$ in said centerline said point also being the TRUE POINT OF BEGINNING of the parcel herein described;

1) South $\mathbf{4}^{\mathbf{0}} \mathbf{0 6}{ }^{\prime} \mathbf{4 4}$ " West a distance of $\mathbf{5 . 0 0}$ feet to a point 35.00 feet right of Station $37+32.00$ in said centerline;
2) North $\mathbf{8 5}^{\circ} \mathbf{5 3}{ }^{\prime} \mathbf{1 6}$ " West a distance of $\mathbf{7 8 . 4 4}$ feet to a point 35.00 feet right of Station $36+53.56$ in said centerline;
3) North $\mathbf{3}^{\circ} \mathbf{5 8}{ }^{\prime} \mathbf{5 3}$ " East a distance of $\mathbf{5 . 0 0}$ feet to a point in the said Grantor's northerly line, also being southerly right-of-way line of Refugee Road being 30.00 feet right of Station 36+53.55 in said centerline;

Of the above described tract 0.009 acres, including 0.000 acres of present road occupied, is located in Auditor's Parcel Number 010-104487-00.

The bearings for this description are based on Grid North, of the Ohio State Plane Coordinate System, South Zone, NAD83(2011) as determined by GNSS measurements tied to the Ohio Department of Transportation's Real-Time-Network. Control for the bearings shown herein were determined by GPS observations and establishing South $85^{\circ} 31^{\prime} 31^{\prime \prime}$ East for the existing centerline of right-of-way of Refugee Road. Bearings are shown to indicate angle only and are for project use only.

All stations referred to herein are from the existing centerline of right-of-way of Refugee Road as shown in plans for project Operation Sidewalks, School Sidewalks - Refugee Road on file with the City of Columbus.
