Situated in the City of Columbus, County of Franklin, and State of Ohio, Half Section 46, Township 12, Range 21 of the Refugee Lands, being a part of an original 42-acre tract of land conveyed to Clarence G. Issemann, Bishop of the Diocese of Columbus, by Deed Book 2567, Page 468, all references being to the Franklin County Recorder's Office, Franklin County, Ohio, and being bounded and more particularly described as follows:

Being a parcel of land lying on the south side of the centerline of existing right-of-way of Refugee Road, being located within the following described points in the boundary thereof;

Beginning, for reference, at a 1" iron pin inside a monument box to be set during construction at the intersection of the existing centerline of right-of-way of Glenbriar Street (50' R/W) and the existing centerline of right-of-way of Refugee Road (60' R/W), being at Station 44+25.22 in said centerline of Refugee Road;

Thence along said centerline of Refugee Road, also partially the Grantor's northly line North 85° 53' 16" West a distance of 174.22 feet to a point at 42+51.00 in said centerline;

Thence leaving said centerline South 4° 06' 44" West a distance of 30.00 feet to a point in the southerly right-of-way line of said Refugee Road being 30.00 feet right of Station 42+51.00 in said centerline, said point also being the **TRUE POINT OF BEGINNING** of the parcel herein described;

Thence along a new line across the Grantor's tract the following six courses:

- 1) **South 4° 06' 44" West** a distance of **13.00 feet** to a point 43.00 feet right of Station 42+51.00 in said centerline;
- 2) **South 82° 48' 08" West** a distance of **10.20 feet** to a point 45.00 feet right of Station 42+41.00 in said centerline;

- 3) **North 79° 46' 21" West** a distance of **28.16 feet** to a point 42.00 feet right of Station 42+13.00 in said centerline;
- 4) **North 85° 53' 16" West** a distance of **49.00 feet** to a point 42.00 feet right of Station 41+64.00 in said centerline;
- 5) **South 87° 59' 48" West** a distance of **56.32 feet** to a point 48.00 feet right of Station 41+08.00 in said centerline;
- 6) **North 27° 19' 03" West** a distance of **21.09 feet** to a point in said southerly right-of-way line 30.00 feet right of Station 40+97.00 in said centerline;

Thence along said line **South 85° 53' 16" East** a distance of **154.00 feet** to the **TRUE POINT OF BEGINNING**, containing 0.047 acres, of which the present road occupies 0.000 acres.

Of the above described tract 0.047 acres, including 0.000 acres of present road occupied, is located in Auditor's Parcel Number 010-104487-00.

The bearings for this description are based on Grid North, of the Ohio State Plane Coordinate System, South Zone, NAD83(2011) as determined by GNSS measurements tied to the Ohio Department of Transportation's Real-Time-Network. Control for the bearings shown herein were determined by GPS observations and establishing South 85°31'31" East for the existing centerline of right-of-way of Refugee Road. Bearings are shown to indicate angle only and are for project use only.

All stations referred to herein are from the existing centerline of right-of-way of Refugee Road as shown in plans for project Operation Sidewalks, School Sidewalks – Refugee Road on file with the City of Columbus.
