WHEREAS, the continuation of the Night Prosecutor Program is a necessary and desirable activity in support of the Criminal Justice System in the City of Columbus; and

WHEREAS, an emergency exists in the usual daily operation of the City Attorney's Office, and that it is immediately necessary to pay this settlement thereby preserving the public health, peace, property, safety and welfare, now, therefore;

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBUS:

SECTION 1. That the City Attorney be and she is hereby authorized and directed to contract on behalf of the City of Columbus with Capital University for services beginning January 1, 1997 for provision of the Consultant Services necessary to continue the operation of the Night Prosecutor Program.

SECTION 2. That the expenditure of the sum of One Hundred Eighteen Thousand One Hundred Fifty Four Dollars (\$118,154.00) or so much thereof as may be necessary for performance of such contract is hereby authorized from Department 24-01, Fund 01-100, Character 03, Minor Object Code 324, Index Code 240119, to pay the cost thereof.

SECTION 3. That for the reasons stated herein, Council finds it to be in the best interest of the City to waive, and therefore waives, Columbus City Code § 329.06.

SECTION 4. That for the reasons stated in the preamble hereto which is made a part hereof, this ordinance is hereby declared to be an emergency measure and shall take effect and be in force from and after passage and approval by the Mayor or ten days after passage if the Mayor neither approves nor vetoes the same.
