

Ordinance Number 0153-2008

American Municipal Power-Ohio contract modification for purchased power.

Information to be included in all Legislation Modifying Contracts:

Bids were not taken for the original contracts. AMP-Ohio is a non-profit organization for state municipalities and, acting as a broker, has contracted on the City's behalf competitive prices through a bidding process.
