The work for which proposals are invited consists of constructing approximately 8500 feet of storm sewers ranging in size from 8" to 76" x 48" elliptical pipe, and approximately 2900 sq. yds of full-width pavement replacement/restoration work, maintaining traffic and other such work as may be necessary to complete the contract in accordance with the plans (CC-13496) and specifications.

4. **A narrative timeline for the contract including a beginning date, beginning and ending dates for known phases of the contract and a projected ending date.**

All work shall be completed within 365 calendar days from date of the Notice to Proceed.

5. **An estimate of the full cost of the Contract including a separate estimate of any and all phases or proposed future contract modifications.**

8. **An explanation of why the work to be performed as part of the contract modification cannot be bid out. (Indicating the work to be a logical extension of the contract is not sufficient explanation.)**

9. **A cost summary to include the original contract amount, the cost of each modification to date (list each modification separately), the cost of the modification being requested in the legislation, the estimated cost of any future known modifications and a total estimate of the contract cost.**

10. **An explanation of how the cost of the modification was determined.**

Note: The Contract should be considered to include any and all work that is anticipated to be awarded to the company awarded the original contract throughout the contract/project timeline. This includes the original contract and any and all future anticipated modifications to the contract to complete the contract/project.
