This memorandum is a recommendation for construction contractor selection and processing the construction legislation for the Pedestrian Safety Improvements – Sidewalk Program project.

Project Scope:

This project consists of citywide tree root related sidewalk repair and crosswalk improvement construction.

Fiscal Impact: Source of funds is 2012 Department of Public Service bonds.

Engineer's estimate + 25% inspection are: \$254,000.00
Low bid amount + 25% inspection are: \$282,915.88

Special Provision 146 in the bid document states, "It is the City's intent to fully utilize the available funding provided to its Sidewalks Program within the approved Capital Improvements Budget. Therefore, the City reserves the right to increase the base contract amount, up to a maximum of (\$203,000.00)....The contract will be awarded to the lowest (determined by the base bid, not including additional funds to equal the maximum of \$203,000.00), best, responsive, responsible bidder per Columbus City Code Section 329."

The contract shall be for the amount of \$203,000.00 with \$51,000.00 for inspection.

Schedule: Bids were opened May 10, 2012; estimated Council date is June 11, 2012; estimated NTP date is July 5, 2012. The contract has a completion date of December 31, 2013.

Engineer's Estimate: \$203,201.02
