# FACT SHEET MAY 2013 DYNAMIT TECHNOLOGIES, LLC

## I. STATEMENT OF PURPOSE – Job Creation

The Department of Development recommends a Downtown Office Incentive of fifty percent (50%) for a period of three (3) years for the purpose of creating 30 new full-time permanent positions and retaining 35 full-time employees.

## II. PROJECT HISTORY

Dynamit Technologies, LLC is privately held company headquartered in the Arena District of downtown Columbus, Ohio. The company was founded in 2004 by Matt Dopkiss, Chief Executive Officer. Dynamit Technologies, LLC is a digital consultancy made up of designers, web developers, strategists, and content specialists that solve complex business challenges for retailers, healthcare organizations, associations, business-to-business companies, start-ups, not-for-profits and professional services with both domestic and international clients. Dynamit Technologies, LLC handles projects from start to finish, offering Web and mobile design and development, Intranet design, user experience, e-commerce, systems integration, and content management.

Dynamit Technologies, LLC is proposing to expand its corporate headquarters in the Arena District by entering into a 5-year lease agreement on a 9,400 sq. ft. vacant office space. The company will invest approximately \$500,000 including leasehold improvements, machinery and equipment, retain 35 full-time jobs and create 30 new full-time permanent positions with an annual payroll of approximately \$2.1 million to meet its increased sales growth and consumer demands.

Dynamit Technologies, LLC is requesting a 50%/3-year Downtown Office Incentive from the City of Columbus to assist in the expansion of its corporate headquarters.

#### III. PROJECT INVESTMENT

#### IV. DECISION & TIMING

The project will begin in November, 2013 with a scheduled time of completion for March 2014, contingent upon Columbus City Council approval of the recommended tax incentive.

## V. EMPLOYMENT

The project will create 30 new full-time permanent positions with an estimated annual payroll of \$2.1 million and retain 35 full-time positions with an annual payroll of approximately \$2.45 million.

Total payroll (retained and new) to Columbus will be approximately \$4.55 million.

Benefits provided to new employees begin first month of employment and includes:

The proposed expansion project will be located at 274 Marconi Blvd. Columbus, Ohio 43215, which is accessible by public transportation (COTA).

# VI. REQUESTED PUBLIC PARTICIPATION

The Department of Development recommends a Downtown Office Incentive equal to fifty percent (50%) of the amount of new employee city income tax withholding for three (3) years.

## VII. WORKFORCE DEVELOPMENT

Employers granted a tax incentive will meet with the Central Ohio Workforce Investment Corporation (COWIC) within 90 days to develop a relationship to assure continuing employment opportunities for Columbus residents who are unemployed or underemployed.
