This memorandum is a recommendation for construction contractor selection and processing the construction legislation for the Roadway Improvements - Tech Center South Techneglas project.

Project Scope:

The work for this contract consists of: construction of new two-lane roadways (1) from Frebis Avenue to Jenkins Avenue and (2) from Jenkins Avenue to Markison Avenue. Roadway (1) will be called Gilbert Street, and (2) S. Ohio Avenue, since they are extensions of the alignments of those existing roadways. The roadways will be constructed using permeable concrete pavers. Construction will include new curb, sidewalk, street lighting, some new storm drainage, and other such work as may be necessary to complete the contract in accordance with the plans and specifications set forth in the Bid Submittal Documents.

Fiscal Impact: Source of funds is 2011 Department of Public Service bonds.

Engineer's estimate + inspection (10%): \$1,618,958.30 Low bid amount + inspection (10%): \$1,360,724.72

Difference between engineer's estimate and bid amount, including inspection: \$258,233.58

<u>Schedule:</u> Bids were opened June 18, 2013; estimated Council date is July 15, 2013; estimated NTP date is August 8, 2013. The contract has a completion date of November 2, 2013.

Bid Evaluation:

In examining the proposal submitted by Thompson Excavation, Ltd., the following anomalies were found. The full names and residential addresses of all persons and parties interested in the foregoing bid were not listed (page 11). The "Top 5 current public or private projects currently in progress" was checked in the negative by the contractor, which should mean they are stating they do not currently have any public or private projects. The "PROPOSED SUBCONTRACTORS" section on page 34 has 4 subcontractors listed but only 2 are completed. Earlier in the document the contractor mentioned only using two subcontractors, so we do not know why four subcontractors were listed later. We consider these to be immaterial.

Recommendation:

With reference to bids received on June 18, 2013, I wish to make the following recommendation for the subject improvement:

Award is made to the lowest responsive and responsible and best bidder, Thompson Excavation, Ltd., for their bid of \$1,237,022.47, which is \$234,757.81 under the Engineer's estimate of \$1,471,780.28.

Thompson Excavation, Ltd. did complete the Construction Contract Subcontractor Report. Two of the subcontractors contacted were chosen to be subcontractors on the project.

Please respond to this e-mail indicating approval of the recommended contractor – Thompson Excavation – or approval of another contractor. If you approve another contractor please provide an explanation.
