Thence N 81°26'39" W a distance of 13.04 feet to a point, said point being 38.00 feet right of station 260+38.00;


Thence N 4°09'26" E a distance of 8.00 feet to the point of beginning;

The basis of bearings in this description is based on GPS observations using the Ohio CORS Network (Ohio South Zone) to determine a grid bearing in the NAD83 (96CORS adjustment) state plane coordinate system. The Columbus, Mount Vernon, and McConnelsville CORS stations were used in determining the grid bearing, and establishing a bearing along the centerline of Joyce Avenue to be S 86°12'13"E (north of 17th Avenue).

All stations and offsets are referenced to the centerline of right of right of way and construction as filed with the City of Columbus and designated as "2768-DR E"
