TEMPORARY CONSTRUCTION EASEMENT FOR THE PURPOSE OF PERFORMING THE WORK NECESSARY TO RECONSTRUCTION STEPS FOR 24 MONTHS FROM THE DATE OF ENTRY BY THE CITY OF COLUMBUS, FRANKLIN COUNTY, OHIO

Situate in the State of Ohio, County of Franklin, City of Columbus, Section 5, Township 5, Range 22, Refugee Lands, and being part of Lot 60 of Collins, Atkinson & Guitner's Addition, as recorded in Plat Book 2, Page 84, in the name of Bryan D. Basom, as described in Instrument No. 200908250124548 and Instrument No. 200809240144131, all records contained herein are on file at the Recorder's Office, Franklin County, Ohio.

Beginning, for reference, at the southwesterly corner of said Lot 60, being the intersection of the northerly existing right of way line of Third Avenue (60' Right of Way) and the easterly existing right of way line of Neil Avenue (80' Right of Way), as shown on said Collins, Atkinson & Guitner's Addition;

Thence, North 08 degrees 15 minutes 14 seconds West, a distance of 13.48 feet, along the westerly line of said Lot 60 and the easterly existing right of way line of said Neil Avenue, to the True Place of **Beginning** for the easement herein described:

Thence, North 08 degrees 15 minutes 14 seconds West, a distance of 8.00 feet, continuing along the westerly line of said Lot 60 and the easterly existing right of way line of said Neil Avenue;

Thence, North 81 degrees 44 minutes 46 seconds East, a distance of 5.00 feet, leaving the easterly existing right of way line of said Neil Avenue, through said Lot 60;

Thence, South 08 degrees 15 minutes 14 seconds East, a distance of 8.00 feet, continuing through said Lot 60, being parallel with and 5.00 feet perpendicular to the easterly existing right of way line of said Neil Avenue;

Thence, South 81 degrees 44 minutes 46 seconds West, a distance of 5.00 feet, continuing through said Lot 60, to the **True Place of Beginning**, containing 0.001 acres (40.00 square feet), more or less, from Franklin County Auditor's Permanent Parcel Number 010-047727-00.

The bearings for this description are based on the bearing between Franklin County Engineer's stations "COC13-83" and "RINGLE" being North 08°32'58" West, as measured using GPS methods and the Ohio State Plane Coordinate System, South Zone, NAD 83 (1986 Adjustment).
