Thence, South 08 degrees 15 minutes 14 seconds East, a distance of 20.70 feet, along the westerly existing right of way line of said Neil Avenue;

Thence, South 81 degrees 44 minutes 46 seconds West, a distance of 12.00 feet, leaving the westerly existing right of way line of said Neil Avenue through said Tenth Avenue (vacated);

Thence, North 08 degrees 15 minutes 14 seconds West, a distance of 60.00 feet, being parallel with and 12.00 feet perpendicular to the westerly existing right of way line of said Neil Avenue, through said Tenth Avenue (vacated), said 1 foot reserve, and said 324.395 acre tract;

Thence, North 81 degrees 44 minutes 46 seconds East, a distance of 12.00 feet, through said 324.395 acre tract, to the westerly existing right of way line of said Neil Avenue;

Thence, South 08 degrees 15 minutes 14 seconds East, a distance of 39.30 feet, along the westerly existing right of way of said Neil Avenue, to the **True Place of Beginning**, containing 0.014 acres (600.92 square feet), more or less, with 0.008 acres (337.75 square feet) being from Franklin County Auditor's Permanent Parcel Number 010-067007-00, 0.00028 acres (12.22 square feet) being from Franklin County Auditor's Permanent Parcel Number 010-045989-00, and 0.00528 acres (250.95 square feet) being from Franklin County Auditor's Permanent Parcel Number 010-045989-00, and 0.00528 acres, 0.00028 acres (12.25 square feet) is from 1' reserve of said William N. King's Neil Avenue Subdivision, and 0.005 acres (238.70 square feet) is from said vacated Tenth Avenue.
