The following information has been provided concerning the City of Columbus' 2013 – 2014 annual objection to the renewal of liquor permits. After reviewing the State of Ohio, Franklin County, and City of Columbus records regarding the above liquor permit establishment, the following information has been complied with regard to a potential objection to the renewal of the permit issued by the State of Ohio.

The above listed liquor establishment has been issued a liquor permit from the Division of Liquor Control # 6292073. The permit holder received a C-1 permit and a C-2 permit. This permit grants the permit holder the privilege to sell alcoholic beverages in the State of Ohio for off premises consumption as described by law.

An "Inquiry of Liquor Violations" was received from the State of Ohio, Division of Liquor Control. The "Inquiry of Violations" revealed that the permit holder has received the following violations:

Case Number 1 / January 8, 2013

The below listed violation has been assigned case #663-13 by the Liquor Control Commission. The Liquor Control Commission held a hearing on September 9, 2012, at which time the Liquor Control Commission sustained the violation of Sale and/or Furnishing to a Person Under 21. The Commission ordered the permit holder to

service a 6 day suspension or to pay a \$1,500 fine. The permit holder did not pay the fine and served the suspension.

Case Number 2 / March 22, 2013

The below listed violation has been assigned case #1108-13 by the Liquor Control Commission. The Liquor Control Commission held a hearing on September 13, 2012, at which time the Liquor Control Commission sustained the violation of Sale and/or Furnishing to a Person Under 21. The Commission ordered the permit holder to service a 10 day suspension or to pay a \$1,500 fine. The permit holder paid the fine.
