The work to be performed under this contract will be the removal of dead and diseased trees and brush for the Department of Public Utilities The work will include trimming and removal of trees in areas serviced by the city.

The work under this Contract shall be completed in a manner acceptable to the City within 730 calendar days after the date of the Notice to Proceed. Subject to mutual agreement, the period covered by the ensuing Contract, under the same terms and conditions can be extended for two (2) additional one-year periods, or portion thereof at the same pricing.

Modification #3– Pending - \$40,000.00

The contract will continue to provide tree trimming and debris removal services by Asplundh for the City of Columbus. This Modification #3 for the Division of Water will provide tree trimming and tree removal and remove a large number of dead and diseased trees along city properties; the majority of which have been damaged by the emerald ash borer blight.
