The DASProtect Sentry is a comprehensive support and maintenance plan for the StackVision and data controller products which are utilized to monitor and report stack emissions of the incinerator smoke stacks at the Jackson Pike and Southerly Wastewater Treatment Plants. This monitoring and reporting of stack emissions helps the Treatment Plants meet its environmental compliance objectives to remain EPA compliant.

An updated contract timeline to contract completion.

The DASProtect Sentry is a comprehensive support and maintenance plan for the StackVision and data controller products which are utilized to monitor and report stack emissions of the incinerator smoke stacks at the Jackson Pike and Southerly Wastewater Treatment Plants. This modification is to provide the funding necessary to cover the support and maintenance plan for the time period of August 1, 2014 through February 28, 2015.

If the contract modification was not anticipated and explained in the original contract legislation a full explanation as to the reasons the work could not have been anticipated is required. Additional funds were foreseen but, due to the fact that the total cost for both Treatment Plants combined exceeds the \$20,000.00 threshold limit, a portion of the yearly cost is required to be legislated.

Southerly Wastewater Treatment Plant had already established a purchasing document for their service agreement with the company, for 2014. Due to this fact, when it was time for the Jackson Pike Wastewater Treatment Plant to establish a purchasing document for their annual service agreement there was not enough funds available under the \$20,000 threshold limit. The necessary funding has been established to provide for support and maintenance from March 1, 2014 through July 31, 2014. It is now necessary to establish additional funding for the time period of August 1, 2014 through February 28, 2015.

Work under this modification is a continuation of services included in the scope of the original agreement.
