Thence S 02°53'21" W a distance of 37.68 feet to a point 43.00 feet right of station 101+34.97;


Thence N 86°39'03" W a distance of 8.13 feet to the point of beginning

The above described area is contained within the Franklin County Auditor's Parcel Numbers 010-098536, 010-098647 and 010-236419. Within said boundary is 0.051 acres, more or less, of which 0.000 acres is in the present road occupied, for a net take of 0.051 acres, more or less.

This description and survey was prepared and reviewed on December 4, 2014 by Robert A. Bosworth, Registered Surveyor #7750.

The basis of bearings in this description is based on GPS observations using the Ohio CORS Network (Ohio South Zone) to determine a grid bearing in the NAD83 (96CORS adjustment) state plane coordinate system. The Columbus, Mount Vernon, and McConnelsville CORS stations were used in determining the grid bearing, and establishing a bearing along the centerline of Joyce Avenue to be N 13°32'54"E (north of 17th Avenue).

All stations and offsets are referenced to the centerline of right-of-way and construction as filed with the City of Columbus and designated as "2906-E".
