The work consists cleaning and overcoating the existing exterior paint schemes on the Henderson East (1MG) & West (1MG) elevated storage tanks and removing and replacing the interior wet coating system and spot repairing and painting the interior dry areas of the Walcutt (2MG) elevated storage tank, and other such work as may be necessary to complete the contract in accordance with the specifications set forth in the Bid Submittal Documents.

Additionally, there are significant paint failures on the interior of the Walcutt 2 MG elevated tank that need addressed as well as paint failures and spot repairs to the interior dry area.
