Introduction:

The City of Columbus, Ohio Department of Technology (City of Columbus) has requested Environmental Systems Research Institute, Inc. (Esri) Professional Services to provide consulting services relating to Esri best practices and recommendations for ArcGIS Platform configuration and deployment. The quote below describes the scope of services, schedule, pricing, terms and conditions, and purchasing instructions.

Scope of Services:

ArcGIS Remote Consulting Support

Esri will provide up to 100 hours of remote consulting services to assist City of Columbus with best practices and recommendations for ArcGIS Platform and configuration and deployment. It is anticipated that consulting services will include the following topics:

- Review current City of Columbus GIS architecture
- Discuss current ArcGIS product implementation
- Best practices for ArcGIS Platform configuration and deployment
- ArcGIS for Server configuration
- Data management in a SQL Server and Oracle environment
- Performance and scalability considerations and recommendations for optimization

This support excludes all travel, and scheduling will be based on resource availability. The Esri consultant(s) will work with direction from City of Columbus technical staff and management via telephone, e-mail, and/or webcast.

City of Columbus understands and agrees that consulting services requiring other burdened direct costs (ODCS) such as travel and actual on-site visit(s) would be priced and contracted separately under the Esri Enterprise Advantage Program Agreement (EAP).

Esri Responsibilities

• Provide up to 100 hours of remote consulting services as described above.

City of Columbus Responsibilities

- Communicate project needs and priorities to the Esri consultant.
- Provide appropriate City of Columbus technical staff to participate.
- Provide all necessary information on hardware and software during this activity.
- Provide the Esri consultant with access to servers and database, as required.

Assumptions

- The workflow scenarios presented by City of Columbus are representative of loads and workflows performed by users.
- The scope of this activity is limited to the GIS system and infrastructure used by City of Columbus.
- Esri Consultant(s) will have access to servers and databases, as required to complete the
 performance assessment.

Schedule:

The schedule(s) for the remote support will be determined by and will be mutually agreed to between the parties' respective Project Managers throughout the term of the engagement. Esri anticipates that the support will be completed by December 31, 2015. Esri understands the importance and timeliness of this effort, and will endeavor to meet City of Columbus schedule goals.

Pricing:

The pricing provided below has been estimated based upon an anticipated award of a Time-and-Materials (T&M) contract. The labor hours for the remote consulting services have been estimated based upon discussions with the City of Columbus technical staff and management. The total not-to-exceed (NTE) price for the quoted Scope of Services is \$31,382.

This quote is valid for a period of 90 days from the submittal date above. This price is exclusive of any applicable federal, state and/or local taxes including any foreign taxes, value-added tax, customs, or duties for which City of Columbus will remain responsible.

Esri anticipates using staff from the Senior GIS System/Software Architect labor category. Depending on the level of expertise required to perform certain activities during this engagement, Esri may be required to utilize other Esri staff members with a different skill-set and labor category. Esri reserves the right to reallocate the project funding accordingly, provided the overall contract price is not exceeded.

Esri will perform and invoice Services on a time and materials basis using the labor categories and rates specified for the performance period. Labor will be invoiced on a monthly basis for actual hours expended during the previous month. Invoices are to be paid within 30 days of receipt.
