- Project Dry Basement Program was implemented and authorized by the Director of Public Utilities to enter into necessary agreements with homeowners and contracts with licensed plumbers to perform work related to the installation of devices that are appropriate for the elimination of water in the basement (WIBs) in residences within the City of Columbus.

It is periodically rebid and the contracts are modified for the ongoing installation of back water valves every 3YEARS.
