## DESCRIPTION OF A 0.046 ACRE PARCEL PARCEL 5-WD

Being a parcel lying on the right side of centerline of Fairwood Avenue.

**Commencing** at an iron pin set on the east line of Half Section 32 and the west line of Half Section 33 at the intersection of Gates Street at centerline station 10+00.00 and Fairwood Avenue at centerline station 25+40.92;

Thence South 04 Degrees 00 Minutes 49 Seconds West 234.64 feet along the centerline of Fairwood Avenue (50' right of way) being the east line of Half Section 32 and the west line of Half Section 33 to the grantors northwest corner at centerline station 23+06.28, said point being the **Point of Beginning** for the parcel herein described;

Thence from the **Point of Beginning** South 86 Degrees 11 Minutes 27 Seconds East 25.00 feet along the grantors north line to an iron pipe found at the southwest corner of Lot No. 4 of Fairgate Subdivision recorded in Plat Book 27, Page 92A conveyed to Blanche M. Wardlaw and Javan E. Wardlaw recorded in Instrument Number 200407080158258 and the east right of way of Fairwood Avenue at 25.00 feet right of centerline station 23+06.37;

Thence South 04 Degrees 00 Minutes 49 Seconds West 79.76 feet along the east right of way of Fairwood Avenue to an iron pin found on the grantors south line and the north line of a 0.819 acre parcel conveyed to Maudie G. Williams recorded in Official Record Volume 9986, Page E10 at 25.00 feet right of centerline station 22+26.61;

Thence leaving the east right of way of Fairwood Avenue North 86 Degrees 11 Minutes 27 Seconds West 25.00 feet along the grantors south line and the north line of said 0.819 acre parcel to the grantors southwest corner, the northwest corner of said 0.819 acre parcel and the centerline of Fairwood Avenue being the east line of Half Section 32 and the west line of Half Section 33 at centerline station 22+26.52;

Thence North 04 Degrees 00 Minutes 49 Seconds East 79.76 feet along the grantors west line, the centerline of Fairwood Avenue, the east line of Half Section 32 and the west line of Half Section 33 to the **Point of Beginning**.

The above described contains 0.046 acres more or less including the present road which occupies 0.046 acres and is contained in Auditors Parcel Number 010-104207-00 which presently shows 0.819 acres.
