**Commencing** at an iron pin set on the east line of Half Section 32 and the west line of Half Section 33 at the intersection of Gates Street at centerline station 10+00.00 and Fairwood Avenue at centerline station 25+40.92;

Thence South 04 Degrees 00 Minutes 49 Seconds West 234.64 feet along the centerline of Fairwood Avenue (50' right of way) being the east line of Half Section 32 and the west line of Half Section 33 to the northwest corner of an 0.819 acre parcel conveyed to Rebecca Milnes recorded in Instrument Number 201301230011902 at centerline station 23+06.28;
