### 5. A description of work performed to date as part of the contract and a full description of work to be performed during any future phasing of the contract.

The Director of Public Utilities entered into a contract with SimplexGrinnell LP, to provide Security System Maintenance Monitoring and Inspection, and the Annual Inspection Plus purchase of Access Control software at the Sewer Maintenance Operations Center locations of 1250 Fairwood Avenue and 1388 Emig Road; and for the performance of inspections, diagnostic tests and repairs for all accessible peripheral devices currently connected to the facility life safety systems at the Jackson Pike and Southerly Wastewater Treatment Plants. These systems include the Fire Alarm Detection Systems, and the Fire Sprinkler Systems. The accessible peripheral devices shall be functionally tested in accordance with the NFPA 72, chapter 10, and manufacturer's recommended procedures. This agreement provides for the repair and necessary documentation to log all accessible components and devices, detector cleaning for fire alarm and detection systems, emergency service call and labor for the fire alarm will be provided 24 hours, 7 days a week, and panel and peripheral component replacement for the various electronic systems, including battery replacement. SimplexGrinnell LP will provide up to 16 hours of Technical Labor at a per hour rate of \$123.00, to assist in loading new access cards for the Sewer Maintenance Operation Center locations of 1250 Fairwood Avenue and 1388 Emig Road.

The regular maintenance of the various life safety systems is required to preserve the expected and planned life for this equipment. The life safety systems provide fire alarm detection and fire sprinkler suppression systems which protect the assets contained in the various facilities. If the systems are not

monitored, inspected and maintained the removal and replacement of the failed equipment would be a major impact to the budget. No community outreach or environmental factors are considered for this project.

The contract will continue to provide Security System Maintenance Monitoring and Inspection, and the Annual Inspection Plus purchase of Access Control software at the Sewer Maintenance Operations Center locations. Additionally, the contract provides for the continuing performance of inspections, diagnostic tests and repairs for all accessible peripheral devices currently connected to the facility life safety systems at the Jackson Pike and Southerly Wastewater Treatment Plants. This modification also provides for up to 16 hours of Technical Labor to assist in loading new access cards at the various Sewer Maintenance Operations Center locations and establishes a contingency fund to be used as necessary if there is a repair identified outside of the service agreement.

10. If the contract modification was not anticipated and explained in the original contract legislation a full explanation as to the reasons the work could not have been anticipated is required. Anticipated modification. The original contract allows for four (4) extension periods on a year to year basis. This modification is to provide yearly funding necessary for the payment of services to be provided through June 30, 2018.

## 11. An explanation of why the work to be performed as part of the contract modification cannot be bid out. (Indicating the work to be a logical extension of the contract is not sufficient explanation.)

SimplexGrinnell is the developer & installer of the security systems and does not allow anyone but their own company employees to work on or make repairs to the systems. The same exact service is required as in the original contract for the Security System Maintenance, Monitoring and Inspection Services. No lower pricing/more attractive terms and conditions are anticipated at this time.

SimplexGrinnell LP submitted a proposal for the Technical Labor to assist in loading new access cards at the various locations for the Sewer Maintenance Operations Center, which is included within this modification.

This contract will be funded incrementally with modifications on approximately an annual basis. Five contract modifications are anticipated at this time. This modification also provides for up to 16 hours of Technical Labor at a per hour rate of \$123.00, to assist in loading new access cards for the Sewer Maintenance Operation Center locations of 1250 Fairwood Avenue and 1388 Emig Road, based on a proposal from SimplexGrinnell LP dated March 3, 2015, and establishes a contingency fund to be used as necessary if there is a repair identified outside of the service agreement.
