The work consists of modifying the existing Briggs Road detention basin to include forebay and micropool, modifying existing storm inlets and outlets, plantings and other such work as may be necessary to complete the contract in accordance with the plans [CC-16926] and specifications. The project area is located on the south side of Briggs Road approximately 1000 feet west of Harrisburg Pike, Hilltop planning area.

6. A narrative timeline for the contract including a beginning date, beginning and ending dates for known phases of the contract and a projected ending date.

Work is to be completed within 365 calendar days after the effective date of the Notice to Proceed.

7. A narrative discussing the economic impact or economic advantages of the project; community outreach or input in the development of the project; and any environmental factors or advantages of the project.

The intent of the project is to improve water quality leaving the basin and reduce basin maintenance.

8. An estimate of the full cost of the Contract including a separate estimate of any and all phases or proposed future contract modifications.

The bid amount and proposed award amount is **\$661,198.44**, including a **20%** construction contingency amount that will be utilized to fund needed and approved changes in the work. No contract modifications are anticipated at this time; however, construction exigency might later compel modification of this contract, if unforeseen difficulties are encountered.
