DESCRIPTION OF A 0.247 ACRE PARCEL PARCEL 41-WD

Situated in the State of Ohio, Franklin County, City of Columbus, lying in Half Section 39, Township 5 N, Range 22 W, being Part of Lot 5 of the Partition Plat of the Lands of John D. Johnson, Deceased filed as Court of Common Please Complete Record volume 362, page 366, and being a 0.247 acre parcel out of a 5.398 acre tract conveyed to Restoration Christian Center Inc. (hereafter referred to as "Grantor") by the instrument filed as Instrument Number 200804300066210 and Instrument Number 200202250049171 (all document references are to the records of Franklin County unless otherwise stated).

Being a parcel of land lying on the right side of the centerline of right of way of Moler Road more particularly described as follows:

COMMENCING FOR REFERENCE at a Mag nail found on the centerline of right-of-way of Moler Road, the said nail being South 86 degrees 15 minutes 34 seconds East at a distance of 155.00 from the intersection of the said centerline of right-of-way of Moler Road with the centerline of right-of-way of Lockbourne Road;

Thence along the said centerline of right-of-way of Moler Road, South 86 degrees 15 minutes 34 seconds East for a distance of 1576.05 feet to a Mag nail set at the intersection of the said centerline of right-of-way of Moler Road with the centerline of right-of-way of Berkeley Road;

Thence continuing along the said centerline of right-of-way of Moler Road, South 86 degrees 15 minutes 34 seconds East for a distance of 187.13 feet to a Mag nail set at the common corner of Lots 4 and 5 of said Johnson Partition Plat, the Grantor's northwesterly corner and at the northeasterly corner of a parcel conveyed to Creative Housing, Inc., an Ohio Non-Profit Corporation by the instrument filed as Official Record volume 32946, page D03, the said nail being at station 29+17.91 of the centerline of right-of-way of Moler Road and being the TRUE POINT OF BEGINNING of the parcel herein described.

Thence along the Grantor's northerly line and along the said centerline of right-of-way, South 86 degrees 15 minutes 34 seconds East for a distance of 336.48 feet to a Mag nail set at the Grantor's northeasterly corner and at the northwesterly corner of a parcel conveyed to Sam J. Ware and Barbara E. Ware by the instrument filed as Official Record volume 05556, pagae J06 being at station 32+54.39 of the centerline of right-of-way of Moler Road;

Thence along the Grantor's easterly line and along the westerly line of the said Sam J. Ware and Barbara E. Ware parcel, South 03 degrees 43 minutes 01 seconds West for a distance of 32.00 feet to an iron pin set being 32.00 feet right of the centerline of right-of-way of Moler Road station 32+54.40;

Thence crossing through the lands of the Grantor, North 86 degrees 15 minutes 34 seconds West for a distance of 336.58 feet to an iron pin set on the common line between said Lots 4 and 5, the Grantor's westerly line, and on the easterly line of the said Creative Housing, Inc., an Ohio Non-Profit Corporation parcel being 32.00 feet right of the centerline of right-of-way of Moler Road station 29+17.81;

Thence along the Grantor's westerly line, the common line between said Lots 4 and 5, and along the easterly line of the said Creative Housing, Inc., an Ohio Non-Profit Corporation parcel, North 03 degrees 54 minutes 00 seconds East for a distance of 32.00 feet to the TRUE POINT OF BEGINNING, containing 0.247 acres, more or less, of which 0.116 acres are contained within the present road occupied, resulting in a net take of 0.131 acres, being 0.156 acres out of Franklin County Auditor's Parcel number 010-112338 and 0.091 acres out of Franklin County Auditor's Parcel number 010-191402.

Grantor claims title by the instrument filed as Instrument Number 200804300066210 and Instrument Number 200202250049171 in the records of Franklin County.

This description was prepared by Russell Koenig, Ohio Registered Professional Surveyor number 8358, and is based on an actual field survey conducted by DLZ Ohio, Inc. in 2011 through 2014 under his direct supervision.

Bearings are based on the Ohio State Plane Coordinate System, South Zone, NAD 83 (2007), with ties to Franklin County Engineer Monuments FRANK 43 and FRANK143 having a relative bearing of South 87 degrees 56 minutes 15 seconds East.

Where described, iron pins set are 5/8" diameter, 30" long, and bear a yellow plastic cap inscribed "DLZ OHIO, INC".

The stations referenced herein are from the plans known as SIDEWALK IMPROVEMENTS OF MOLER ROAD on file with the City of Columbus.
