DESCRIPTION OF A 0.007 ACRE TEMPORARY EASEMENT PARCEL 63-T

Situated in the State of Ohio, Franklin County, and being a 0.007 acre parcel out of a 0.217 acre tract known as Franklin County Auditor's Parcel number 010-143109 conveyed to Johnny L. Sinkfield Sr. and Denise Sinkfield (hereafter referred to as "Grantor") by the instrument filed as Instrument Number 201411070148683 (all document references are to the records of Franklin County unless otherwise stated).

Being a parcel of land lying on the right side of the centerline of right of way of Moler Road more particularly described as follows:

BEGINNING at and iron pin set on Grantor's northwesterly corner, and on the proposed southerly right-of-way line of Moler Road, the said iron pin being 30.00 feet right of the centerline of right-of-way of Moler Road station 42+26.07 and being the TRUE POINT OF BEGINNING of the parcel herein described.

Thence crossing through the lands of the Grantor and along the proposed southerly right-of-way line of Moler Road, South 86 degrees 17 minutes 17 seconds East for a distance of 63.00 feet to an iron pin set on the Grantor's easterly line being 30.00 feet right of the centerline of right-of-way of Moler Road station 42+89.07;

Thence along the Grantor's easterly line, South 03 degrees 23 minutes 58 seconds West for a distance of 5.00 feet to a point on the Grantor's easterly line being 35.00 feet right of the centerline of right-of-way of Moler Road station 42+89.09;

Thence through the lands of the Grantor, North 86 degrees 17 minutes 17 seconds West for a distance of 63.00 feet to a point on the Grantor's westerly line being 35.00 feet right of the centerline of right-of-way of Moler Road station 42+26.09;

Thence along the Grantor's westerly line, North 03 degrees 23 minutes 58 seconds East for a distance of 5.00 feet to the TRUE POINT OF BEGINNING, containing 0.007 acres, more or less, of which 0.000 acres are in the present road occupied.

The above described parcel contains 0.007 acres, of which 0.000 acres are contained within the present road occupied, resulting in a net take of 0.007 acres out of Franklin County Auditor's Parcel number 010-143109.

Grantor claims title by the instrument filed as Instrument Number 201411070148683 in the records of Franklin County.

This description was prepared by Russell Koenig, Ohio Registered Professional Surveyor number 8358, and is based on an actual field survey conducted by DLZ Ohio, Inc. in 2011 through 2014 under his direct supervision.

Bearings are based on the Ohio State Plane Coordinate System, South Zone, NAD 83 (2007), with ties to Franklin County Engineer Monuments FRANK 43 and FRANK143 having a relative bearing of South 87 degrees 56 minutes 15 seconds East.

Where described, iron pins set are 5/8" diameter, 30" long, and bear a yellow plastic cap inscribed "DLZ OHIO, INC".

The stations referenced herein are from the plans known as SIDEWALK IMPROVEMENTS OF MOLER ROAD on file with the City of Columbus.
