Situated in the State of Ohio, Franklin County, City of Columbus, Section 15, Township 4 North, Range 22 West of the Congress Lands, being part of Reserve A of Southern Pines, Section No. 1 as recorded in Plat Book volume 36, page 32, and being a 0.008 acre parcel out of a 2.850 acre tract known as Franklin County Auditor's Parcel number 010-070450 conveyed to The Parsons Baptist Church (hereafter referred to as "Grantor") by the instrument filed as Deed Book 2498, Page 351 (all document references are to the records of Franklin County unless otherwise stated).

Being a parcel of land lying on the right side of the centerline of construction and right of way of Parsons Avenue more particularly described as follows:

BEGINNING at a point on the Grantor's westerly line and the easterly right of way line of Parsons Avenue, said point being referenced by the Grantor's northwest corner being North 03 degrees 56 minutes 39 seconds East at a distance of 28.79 feet, said point also being 40.00 feet right of the centerline of construction and right of way of Parsons Avenue station 118+72.00 and being the TRUE POINT OF BEGINNING of the parcel herein described;
