[Surveyor's description of the premises follows]

Situated in the State of Ohio, Franklin County, City of Columbus, Section 15, Township 4 North, Range 22 West of the Congress Lands, and being a 0.057 acre parcel out of a 0.500 acre tract known as Franklin County Auditor's Parcel number 010-111547 conveyed to David A. Landis (hereafter referred to as "Grantor") by the instrument filed as Instrument Number 200304140107775 (all document references are to the records of Franklin County unless otherwise stated).

Being a parcel of land lying on the right side of the centerline of construction and right of way of Parsons Avenue more particularly described as follows:

COMMENCING FOR REFERENCE at a point at the intersection of the centerline of right of way of Parsons Avenue and the centerline of right of way of Chatterly Lane, the said point being referenced by a 5/8" iron pin found to be South 86 degrees 02 minutes 32 seconds East at a distance of 1.65 feet;

Thence along the said centerline of right of way of Parsons Avenue, South 03 degrees 48 minutes 27 seconds West for a distance of 330.09 feet to a Mag nail set at the Grantor's northwesterly corner and the southwesterly corner of a parcel conveyed to Deanna Kay Caplinger by the instrument filed as Official Record volume 29119, page I05, the said Mag nail being at centerline of construction and right of way of Parsons Avenue station 130+07.94 and being the TRUE POINT OF BEGINNING of the parcel herein described.

Thence along the Grantor's northerly line and the southerly line of the said Deanna Kay Caplinger parcel, South 86 degrees 31 minutes 33 seconds East for a distance of 30.00 feet to a 1/2" iron pin found being 30.00 feet right of the centerline of construction and right of way of Parsons Avenue station 130+08.12;

Thence crossing through the lands of the Grantor, South 03 degrees 48 minutes 27 seconds West for a distance of 82.50 feet to an iron pin set on the Grantor's southerly line being 30.00 feet right of the centerline of construction and right of way of Parsons Avenue station 129+25.62;

Thence along the Grantor's southerly line, North 86 degrees 31 minutes 33 seconds West for a distance of 30.00 feet to a Mag nail set at the Grantor's southwesterly corner being at centerline of construction and right of way of Parsons Avenue station 129+25.44;

Thence along the Grantor's westerly line and the said centerline of right of way of Parsons Avenue, North 03 degrees 48 minutes 27 seconds East for distance of 82.50 feet to the TRUE POINT OF BEGINNING, containing 0.057 acres, more or less, of which 0.048 acres are in the present road occupied.

The above described parcel contains 0.057 acres, of which 0.048 acres are contained within the present road occupied, resulting in a net take of 0.009 acres out of Franklin County Auditor's Parcel number 010-111547.

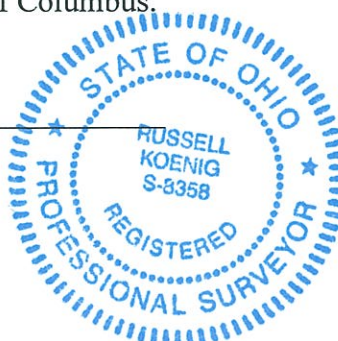
Grantor claims title by the instrument filed as Instrument Number 200304140107775 in the records of Franklin County.

This description was prepared by Russell Koenig, Ohio Registered Professional Surveyor number 8358, and is based on an actual field survey conducted by DLZ Ohio, Inc. in 2011 through 2014 under his direct supervision.

Bearings are based on the Ohio State Plane Coordinate System, South Zone, NAD 83 (2007), with ties to Franklin County Engineer Monuments FCGS 0013 and FCGS 5210 having a relative bearing of North 03 degrees 48 minute 27 seconds East.

The stations referenced herein are from the plans known as FRA-PARSONS AVENUE SIDEWALKS on file with the City of Columbus.
