Situated in the State of Ohio, Franklin County, City of Columbus, Section 15, Township 4 North, Range 22 West of the Congress Lands, and being a 0.103 acre parcel out of a 4.864 acre tract known as Franklin County Auditor's Parcel number 010-111552 conveyed to Junior G. Kelly and Betty June Obert, Co-Trustees of The Kelly Family Trust U/A/G DTD. December 10, 2003 (hereafter referred to as "Grantor") by the instrument filed as Instrument Number 201106070071577 (all document references are to the records of Franklin County unless otherwise stated).

Being a parcel of land lying on the right side of the centerline of construction and right of way of Parsons Avenue more particularly described as follows:

COMMENCING FOR REFERENCE at a point at the intersection of the centerlines of right of way of Parsons Avenue and Crowley Road, said point being on the west line of Section 15 and the Grantor's westerly line, said point being referenced by a bent railroad spike found to be North 13 degrees 34 minutes 00 seconds West at 0.04 feet, said point being at centerline of construction and right of way of Parsons Avenue station 144+62.95 and being the TRUE POINT OF BEGINNING of the parcel herein described.

Thence along the Grantor's westerly line, North 03 degrees 48 minutes 27 seconds East for a distance of 73.48 feet to a Mag nail set at the Grantor's northwesterly corner and the southwesterly corner of a parcel conveyed to Thomas A. McDowell and Diane A. Hornung by the instrument filed as Official Record volume 31142, page H08, said Mag nail being at centerline of construction and right of way of Parsons Avenue station 145+36.43;

Thence along the Grantor's northerly line and the southerly line of the said Thomas A. McDowell and Diane A. Hornung parcel, South 86 degrees 06 minutes 22 seconds East for a distance of 30.00 feet to a point being 30.00 feet right of the centerline of construction and right of way of Parsons Avenue station 145+36.38, said point being referenced by a 3/4" bent pipe found to be North 86 degrees 30 minutes 37 seconds East at a distance of 0.25 feet;

Thence crossing through the lands of the Grantor, South 03 degrees 48 minutes 27 seconds West for a distance of 150.03 feet to a point on the Grantor's southerly line and the northerly line of a parcel conveyed to Thomas A. McDowell and Diane Hornung by the instrument filed as Official Record volume 31142, page H08 and being 30.00 feet right of the centerline of construction and right of way of Parsons Avenue station 143+86.35, said point being referenced by a 3/4" bent iron pipe found to be South 60 degrees 45 minutes 50 seconds East at a distance of 0.30 feet;

Thence along the Grantor's southerly line and the northerly line of the said Thomas A. McDowell and Diane Hornung parcel, North 86 degrees 06 minutes 22 seconds West for a distance of 30.00 feet to a Mag nail set at the Grantor's southwesterly corner, the northwesterly corner of the said Thomas A. McDowell and Diane Hornung parcel, and on the centerline of right of way of Parsons avenue, said Mag nail being at centerline of construction and right of way of Parsons Avenue station 143+86.40;

Thence along the Grantor's westerly line and the said centerline of right of way of Parsons Avenue, North 03 degrees 48 minutes 27 seconds East for a distance of 76.55 feet to the TRUE POINT OF BEGINNING, containing 0.103 acres, more or less, of which 0.086 acres are in the present road occupied.

The above described parcel contains 0.103 acres, of which 0.086 acres are contained within the present road occupied, resulting in a net take of 0.017 acres out of Franklin County Auditor's Parcel number 010-111552.

Grantor claims title by the instrument filed as Instrument Number 201106070071577 in the records of Franklin County.

This description was prepared by Russell Koenig, Ohio Registered Professional Surveyor number 8358, and is based on an actual field survey conducted by DLZ Ohio, Inc. in 2011 through 2014 under his direct supervision.

Bearings are based on the Ohio State Plane Coordinate System, South Zone, NAD 83 (2007), with ties to Franklin County Engineer Monuments FCGS 0013 and FCGS 5210 having a relative bearing of North 03 degrees 48 minute 27 seconds East.
