Rhoden (hereafter referred to as "Grantor") by the instrument filed as Instrument Number 200105040097091 (all document references are to the records of Franklin County unless otherwise stated).

Being a parcel of land lying on the right side of the centerline of construction and right of way of Parsons Avenue more particularly described as follows:

BEGINNING at a point at the Grantor's northwest corner and on the existing easterly right of way line of Parsons Avenue, the said point being 40.00 feet right of the centerline of construction and right of way of Parsons Avenue station 179+16.48 and being the TRUE POINT OF BEGINNING of the parcel herein described.
