The purpose of this project is to construct necessary improvements to the water distribution system in the Fenway Road area. The improvements identified in the scope of work will replace water lines that have high break histories and require frequent maintenance. This project includes installation of approximately 3,600 linear feet of 6-inch water main and appurtenances and 5,800 linear feet of 8-inch water main and appurtenances and other such work as may be necessary to complete the contract, in accordance with the plans and specifications set forth in the Invitation for Bid (IFB).

This project is in the Clintonville area and encompasses portions of 6 streets including: Fenway Road, Broad Meadows Boulevard, Highfield Drive, Sunnyside Lane, Fenway Court, and Milton Avenue.
