This Work generally shall include: the agronomic land application of up to 10% Total Solids (TS) liquid biosolids, tank pumping and cleaning services, the transport of 25% TS dewatered biosolids cake and the transport of incinerator ash. The Contractor is responsible for professional management of the LAND APPLICATION WITH REGIONAL STORAGE program, which generally includes preparing site authorization requests, samples, daily activity reports, weekly progress reports, invoices and submitting this information to the City's Project Manager.

The contract will continue to provide Land Application of Biosolids with Regional Storage for various Division of Sewerage and Drainage facilities.

Anticipated modification. The original contract allows for nine (9) extension periods on a year to year basis. This funding increase is required due to Incinerator failure at Southerly Wastewater Treatment Plant in March 2015 therefore requiring excess biosolids generated at the WWTPs to be hauled and disposed of at various locations as required and designated by the City. This service is required only intermittently when other beneficial uses are not available or when plant maintenance is required. This modification will provide the additional funding necessary for the payment of services through August 11, 2016.

An explanation of why the work to be performed as part of the contract modification cannot be bid out. (Indicating the work to be a logical extension of the contract is not sufficient explanation)

The same exact service is required as originally detailed in the RFP. No lower pricing/more attractive terms and conditions are anticipated at this time.

This contract will be funded incrementally with modifications on approximately an annual basis. Nine additional contract modifications are anticipated at this time.
