This contract provides the Division of Water with Professional Construction Management (PCM) services to assist the Division with managing a capital improvements program consisting of multiple projects at multiple facilities. The PCM team shall furnish all necessary personnel, equipment, and materials to perform the work, which will generally consist of Program Support Services, Design Phase Support Services, and Construction Management Services.

Projects scheduled to receive PCM services under this program currently include the following: HCWP Standby Power Improvements, DRWP Standby Power Improvements, HCWP UV Disinfection Improvements, DRWP UV Disinfection Improvements, HCWP Hypochlorite Conversion Project, and the PAWP Hypochlorite Conversion Project. Additional projects may be added to the program in response to changes in the Division's needs or priorities.

This project will perform work "City-Wide" at multiple Division of Water facilities, so there is not a single planning area associated the project.

6. <u>A narrative timeline for the contract including a beginning date, beginning and ending dates for known phases of the contract and a projected ending date.</u>

This contract provides multi-phase services for multiple capital improvement projects that begin and end at different times. This legislation (for the initial contract) will fund the first year (first quarter 2016 to first quarter 2017) of this multi-year contract. The Division anticipates requesting additional modifications on a yearly basis to fund services through 2020 or until PCM services for the last capital improvement project have been completed.

This project provides Professional Construction Management services for multiple capital improvements projects related to the drinking water supply and treatment systems. These projects represent a significant capital investment into the City's water supply infrastructure and will enhance the safety, reliability, and public health protection of the water supply system. All of these functions are tied to the economic vitality of the service area.

This project includes a contractor / vendor outreach program to increase awareness of upcoming construction contracts among small and minority businesses, to provide venues to connect small and minority business with prime contractors, and encourage small and minority businesses participation in the bidding process.

The consultant team has identified a commitment to the Mayor's Green Initiative in their business practices, including recycling programs in their offices, a commitment to double sided printing, and utilization of Project Management Information System (PMIS) for submittal reviews which limits the need for printing documents for review.
