This project consists of removing sludge from Lagoon No. 1 and potentially a portion of the sludge in Lagoon No. 2 at the Hap Cremean Water Plant (HCWP), and other such work as may be necessary to complete the contract, in accordance with the plans Contract No. 2108 and specifications set forth in this Invitation for Bid (IFB).

The planning area for this project is "Citywide" since the HCWP provides water to several communities.

6. A narrative timeline for the contract including a beginning date, beginning and ending dates for known phases of the contract and a projected ending date.

Contract work is required to be completed in a manner acceptable to the City within 150 days from the date that a Notice To Proceed (NTP) is given by the City.
