This is a contract for construction services to address the gravel parking lot and boat ramp at Twin Bridges facility located at Hoover Reservoir. This project will replace gravel lot with permeable concrete and asphalt and replacing the gravel boat launch with engineered erosion control materials. The work consists of the removal of existing gravel and asphalt pavement (access roadway) and installation of new permeable concrete pavement; asphalt pavement; engineered materials for erosion control; Green Infrastructure stormwater facilities; pavement marking; and associated construction work including maintenance of traffic, sediment and erosion control, and other such work as may be necessary to complete the work.

The Twin Bridges facility at Hoover Reservoir is located outside the corporate limits of the City of Columbus and does not have an associated planning area.
