## BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBUS:

**SECTION 1.** That the Director of Recreation and Parks be and is hereby authorized and directed to grant consent on behalf of the City of Columbus to the following organization to apply for appropriate liquor permit to enable the non-profit group to sell alcoholic beverages during the hours specified in said permits and at a specified locations during their 2016 special event:

1) Equitas Health for the PromoWest Festival, July 15-17.
