3. **North 35 degrees 02 minutes 12 seconds West**, a distance of **16.82 feet** to an iron pin set on the existing south right-of-way line for Lazelle Road as established by said 0.368 acre right-of-way parcel, being the north line of the grantor's land, said iron pin set being 40.00 feet right of Lazelle Road proposed centerline of construction Station 90+72.01;

Iron pins set are 5/8 inch diameter by 30 inch long rebar with caps stamped "R/W STRUCTUREPOINT".

The bearings described herein are based on the bearing of South 86 degrees 25 minutes 36 seconds East between Franklin County Monuments "FCGS 2225" and "FCGS 2226", as established utilizing a field traverse.
