## TEMPORARY CONSTRUCTION EASEMENT PARCEL 29-T 0.0148 ACRE TRACT (642.7 S.F.) EXHIBIT "A"

Situate in the City of Columbus, County of Franklin, State of Ohio, Virginia Military Survey No. 971, being part of Lot No. 15, Block No. 4 of Wilshire Heights Subdivision as recorded in Plat Book 15, Page 32 and conveyed to Craig R. Alger by deed recorded in Instrument No. 200204170097391 (all references to deeds, microfiche, plats, surveys, etc. refer to the records of the Franklin County Recorder's Office, unless noted otherwise) and being more particularly bounded and described as follows:

Commencing for reference at the southeast corner of said Lot No. 15, being at the intersection of the north right of way line of Mound Street (50' public right of way, originally dedicated as Dartmoor Road, see City of Columbus Ordinance No. 196-43) with the west right of way line of Warren Avenue (50' public right of way);

thence along the south line of said Lot No. 15 and the north right of way line of said Mound Street, North eighty-one degrees forty-five minutes fifty-nine seconds West (N81°45'59"W) for ten and 00/100 feet (10.00') to the **TRUE POINT OF BEGINNING** of the herein described tract of land;

thence continuing along said lines, North eighty-one degrees forty-five minutes fifty-nine seconds West (N81°45'59"W) for one hundred five and 1/100 feet (105.01') to the southwest corner of said Lot No. 15, being the intersection of the north right of way line of said Mound Street with the east right of way line of the 1st Alley West of Warren Avenue (16' public right of way);

thence along the west line of said Lot No. 15 and the east right of way line of said Alley, North eight degrees fourteen minutes one second East (N08°14'01"E) for five and 00/100 feet (5.00');

thence leaving said lines across said Lot No. 15 for the following four (4) courses:

- 1. South eighty-one degrees forty-five minutes fifty-nine seconds East (S81°45'59"E) for seventy-six and 45/100 feet (76.45');
- North eight degrees fourteen minutes one second East (N08°14'01"E) for three and 00/100 feet (3.00');
- 3. South eighty-one degrees forty-five minutes fifty-nine seconds East (S81°45'59"E) for thirty-six and 56/100 feet (36.56');

4. South fifty-three degrees fourteen minutes one second West (S53°14'01"W) for eleven and 31/100 feet (11.31') to the **TRUE POINT OF BEGINNING**, containing 0.0148 acres (642.7 S.F.), more or less, subject however to all covenants, conditions, restrictions, reservations and easements contained in any instrument of record pertaining to the above described tract of land.

Bearings are based upon the Ohio State Plane Coordinate System, South Zone, NAD83 (2007). Said bearings originated from said coordinate system by GPS observations and observations of Franklin County Survey Monuments 5/14 and COC 1-83. The portion of the centerline of Mound Street stretching west to east from Binns Boulevard to Ogden Avenue, having a bearing of S81°45′59″E, is designated the "Basis of Bearing" for this description.
