Commencing for reference at a 1" iron pin found at the northeast corner of said Lot No. 1, being at the intersection of the south right of way line of Mound Street (50' public right of way, originally dedicated as Dartmoor Road, see City of Columbus Ordinance No. 196-43) with the west right of way line of Warren Avenue (50' public right of way);

thence along the north line of said Lot No. 1 and the south right of way line of said Mound Street, North eighty-one degrees forty-five minutes fifty-nine seconds West (N81°45'59"W) for ten and 00/100 feet (10.00') to the **TRUE POINT OF BEGINNING** of the herein described tract of land;

thence leaving said lines across said Lot No. 1 for the following four (4) courses:

- 1. South thirty-six degrees twenty-eight minutes fifty seconds East (S36°28'50"E) for seven and 4/100 feet (7.04');
- 2. North eighty-one degrees forty-five minutes fifty-nine seconds West (N81°45'59"W) for ninety-two and 67/100 feet (92.67');
- 3. South eight degrees fourteen minutes one second West (\$08°14'01"W) for five and 00/100 feet (5.00');
- 4. North eighty-one degrees forty-five minutes fifty-nine seconds West (N81°45'59"W) for seventeen and 29/100 feet (17.29') to the west line of said Lot No. 1 and the east right of way line of the 1st Alley West of Warren Avenue (16' public right of way);

thence along said lines, North eight degrees fourteen minutes one second East (N08°14'01"E) for ten and 00/100 feet (10.00') to the northwest corner of said Lot No. 1, being the intersection of the south right of way line of said Mound Street with the east right of way line of said Alley;

thence along the north line of said Lot No. 1 and the south right of way line of said Mound Street, South eighty-one degrees forty-five minutes fifty-nine seconds East (S81°45'59"E) for one hundred five and 1/100 feet (105.01') to the **TRUE POINT OF BEGINNING**, containing 0.0143 acres (623.9 S.F.), more or less, subject however to all covenants, conditions, restrictions, reservations and easements contained in any instrument of record pertaining to the above described tract of land.

Bearings are based upon the Ohio State Plane Coordinate System, South Zone, NAD83 (2007). Said bearings originated from said coordinate system by GPS observations and observations of Franklin County Survey Monuments 5/14 and COC 1-83. The portion of the centerline of Mound Street stretching west to east from Binns Boulevard to Ogden Avenue, having a bearing of S81°45′59″E, is designated the "Basis of Bearing" for this description.
