Commencing for reference at a drill hole set at the northeast corner of said Lot No. 417, being at the intersection of the south right of way line of Mound Street (50' public right of way, originally dedicated as Dartmoor Road, see City of Columbus Ordinance No. 196-43) with the east right of way line of Richardson Avenue (50' public right of way);

thence along the north line of said Lot No. 417 and the south right of way line of said Mound Street, North seventy-six degrees forty-five minutes fifty-seven seconds West (N76°45'57"W) for twenty-eight and 48/100 feet (28.48') to an iron pin set at the **TRUE POINT OF BEGINNING** of the herein described tract of land;

thence leaving said lines across said Lot No. 417, South thirteen degrees fourteen minutes three seconds West (S13°14'03"W) for one and 50/100 feet (1.50') to an iron pin set;

thence continuing across said Lot No. 417, North seventy-six degrees forty-five minutes fifty-seven seconds West (N76°45'57"W) for fourteen and 83/100 feet (14.83') to an iron pin set;

thence continuing across said Lot No. 417, North thirteen degrees fourteen minutes three seconds East (N13°14'03"E) for one and 50/100 feet (1.50') to an iron pin set on the north line of said Lot No. 417 and the south right of way line of said Mound Street;

thence along said lines, South seventy-six degrees forty-five minutes fifty-seven seconds East (S76°45'57"E) for fourteen and 83/100 feet (14.83') to the **TRUE POINT OF BEGINNING**, containing 0.0005 acres (22.2 S.F.), more or less, subject however to all covenants, conditions, restrictions, reservations and easements contained in any instrument of record pertaining to the above described tract of land.

Iron pins set are 5/8" rebar, 30" in length, with a plastic plug placed on top inscribed with the name "WOOLPERT INC", unless otherwise noted. All monuments found are in good condition unless otherwise noted.

Bearings are based upon the Ohio State Plane Coordinate System, South Zone, NAD83 (2007). Said bearings originated from said coordinate system by GPS observations and observations of Franklin County Survey Monuments 5/14 and COC 1-83. The portion of the centerline of Mound Street stretching west to east from Binns Boulevard to Ogden Avenue, having a bearing of S81°45′59″E, is designated the "Basis of Bearing" for this description.
