BEGINNING at a drill hole set at the northeast corner of said Lot No. 340, being at the intersection of the south right of way line of Mound Street (50' public right of way, originally dedicated as Dartmoor Road, see City of Columbus Ordinance No. 196-43) with the west right of way line of Terrace Avenue (50' public right of way);

thence along the east line of said Lot No. 340 and the west right of way line of said Terrace Avenue, South thirteen degrees five minutes three seconds West (\$13°05'03"W) for ten and 00/100 feet (10.00') to an iron pin set;

thence leaving said lines across said Lot No. 340, North thirty-one degrees fifty minutes twenty-seven seconds West (N31°50'27"W) for fourteen and 16/100 feet (14.16') to an iron pin set on the north line of said Lot No. 340 and the south right of way line of said Mound Street;

Iron pins set are 5/8" rebar, 30" in length, with a plastic plug placed on top inscribed with the name "WOOLPERT INC", unless otherwise noted. All monuments found are in good condition unless otherwise noted.

Bearings are based upon the Ohio State Plane Coordinate System, South Zone, NAD83 (2007). Said bearings originated from said coordinate system by GPS observations and observations of Franklin County Survey Monuments 5/14 and COC 1-83. The portion of the centerline of Mound Street stretching west to east from Binns Boulevard to Ogden Avenue, having a bearing of S81°45′59″E, is designated the "Basis of Bearing" for this description.
